EMS Uniforms

The following answers questions and clarifies information contained within the original bidding document released for this project. Bidders should consider all information contained within issued addenda when considering their proposal and acknowledge receipt of all addenda in the space provided in the bid form - failure to do so does not relieve vendor from any responsibility to perform the project for the bid price offered. Information provided in this addendum will be incorporated into the contract. This addendum consists of two pages.

GENERAL INFORMATION:

1. Q. The Proper ICE Polos will need pricing for Logo and reflective material. Do you have any specifications for these two work lines or a picture of what is currently on the polos?
A. Pictures for the Logo and Reflective material are below. The "EMS" Logo is 3" tall and the "Iredell County" reflective is 2" tall.
2. Q. The 5.11 Job Shirt has an embroidery line that needs to be priced. Do you have the specifications or picture for that item also?
A. The embroidery is the logo that is on the polo shirts. Logo and embroidery are the same design. Picture below.
3. Q. To be clear, invoices are paid net 30 after an approved invoice is received, physically, from departments opposed to be paid net 30 from invoice date of approved invoice?
A. Invoices are paid net 30 after the invoice date on an approved invoice. If interested, invoices may be emailed to the department and Iredell County has available EFT payment set up available for a quicker payment turnaround.
4. Q. Is it understood that at the time of ordering, even with kept back stock for purposes only of Iredell County orders, that some items due to manufacturer availability may impose extended timing between ordering and delivery of said items to Iredell County? All if any extended timing will be made transparent to Iredell County.
A. It will be the responsibility of the awarded company to keep in stock uniforms that are readily needed for ordering. Should there be a manufacturer delivery delay – Iredell County EMS must be notified. It is in the best interest of the awarded company to order and keep stock to avoid this issue and provide the best turnaround time to the County. The contract terms will remain.

5. Due to the nature of many manufacturer terms of raw materials, we would like to inquire about a percentage of down payment for orders placed. While small orders, due to back stock kept, will be the norm, large orders will be handled according to manufacturer specifications. From particular sources many times due to the mere nature of an order or product, manufacturers do require initial payment.

A. Iredell County terms and conditions for payment will remain according to the contract language. Iredell County will make full payment for all orders after receipt of delivery and inspection of order. Additional Note: when using the online store, Iredell County will be invoiced for orders, same payment terms apply. Also see Question #3 for quicker payment process.
