Iredell County (Owner) is requesting Bids for the construction of the following Project:

Water and Sewer Extensions to Serve Jennings Park
Part 1: City of Statesville Sewer System Extension
Part 2: Iredell Water Corporation Waterline Extension

Bids for the construction of the Project will be received at the office of the **Iredell County Purchasing Officer**, located at **Iredell County Government Center Building, 200 South Center Street, Statesville, NC 28677**, until **Wednesday, November 29th, 2023 at 2:00 PM** local time. At that time the Bids received will be **publicly** opened and read **in the Commissioners' Meeting Room (upstairs)**.

The Project includes the following Work:

Part 1: Approximately 12,231 LF of 16", 12", and 8" gravity sewer, 655 LF of steel bored encasement, 560 LF of storm drain pipe, erosion control, and appurtenances.

Part 2: Approximately 1,740 LF of 8" waterline along Deitz Rd, two 8" x 4" taps with 4" waterline extended across Deitz Rd, and appurtenances.

Funding for this project will be made in whole or part with American Rescue Plan Act (ARPA) federal aid. The Project has an expected duration of **270** days.

A non-mandatory Pre-bid Conference has previously been held.

Bidding Documents are available on compact disc (as portable document format (PDF) files) for a non-refundable charge of **\$50** including shipping via overnight express service. An additional charge will be required for special shipping services requested by a Prospective Bidder.
